Chapter 411. Subchapter F. TEXAS GOVERNMENT CODE controls the use of CCH by DPS. That statute follows the national model established in federal regulations for the nationwide criminal history file managed by the FBI. In addition, certain federal statutes affect the use of TEXAS CCH. The CCH data in the Texas state repository at DPS may only be disseminated from DPS:

1. To criminal justice agencies for criminal justice purposes, including law enforcement agencies during investigations.
2. To entities identified in the Government Code (and a few other statutes) for background searches for specific non-criminal justice purpose, such as:
  1. Certain governmental licenses (medical, law educator, etc.)
  2. Certain jobs serving vulnerable populations, especially children, the elderly and the disabled (daycare centers, nursing homes, hospitals, mental health workers, etc.)
  3. Certain security sensitive jobs, such as nuclear power plants, financial institutions, etc.
  4. Brady firearm sales
3. To the person himself or herself
4. For certain research purposes.
